Sir,

While acknowledging receipt of your letter bearing on the reference and subject supra,

I have the honor to inform you of my approval of the collaboration between the Ministry of Public Health and the African Empowerment and Development Association "AEDA". The domains of collaboration include the following:

- Expanding health awareness through sports and culture;
- Training of community relay actors to cater for mental health conditions;
- Provide infrastructure to handle mental health conditions ;
- Reduce stigma of persons having a mental health condition;
- Develop and implement special mental health programs including psychotherapy, cognitive behavioral therapy, medications and rehabilitation therapy;
- Raising awareness on mental illness as a major impairment to wellness of the population;
- Capacitate health profession on early diagnosis of mental conditions prematurely.

To this effect, you are expected to comply with the rules and regulations in force and equally conform to the health sector strategy document and the road map of the Ministry of Public Health as well as work concertedly with devolved services of the Ministry of Public Health at all levels.

This letter does not automatically guarantee the right to a state subvention. It does not equally substitute the requirements to create, to open a health structure, nor those to acquire, distribute and commercialize drugs and medical disposables.

In any case, an implementation contract could be signed within this collaboration for the realization of joint projects having the necessary financial resources.

Any violations to the terms of this letter shall be tantamount to its withdrawal after informing you.
